## Montezuma Audubon Center Youth Camps Code of Conduct

The Montezuma Audubon Center (MAC) Youth Camps are designed for all campers to have fun and learn new experiences. The MAC Staff have worked hard to give the campers a variety of activities to increase their appreciation of the outdoors. The MAC staff requires all campers to treat each other and MAC staff/camp guides with respect. However, when a camper is being disrespectful or demonstrating a poor attitude toward other campers and/or MAC staff and camp guides, it affects all the campers. Therefore, the following actions are prohibited at camp:

### Prohibited Actions:

- Deliberately causing harm to another person;
- Name calling;
- Teasing other campers;
- Profanity or use of derogatory terms;
- Pushing, shoving, or any unwanted touching;
- Arguing with other campers;
- Talking back or arguing with MAC staff or camp guides;
- Dangerous activities on or near water during paddling activities.

### Corrective Action:

**First Offense:** Camper will be talked to by MAC staff and parents will be notified.

- If camper immediately continues behavior or argues with MAC staff and/or camp guides, a Second Offense Corrective Action will be considered;
- If a camper is deliberately causing harm to another person, Second Offense Corrective Action will immediately be enforced;
- If a camper is acting dangerously on or near water during paddling activities, Second Offense Corrective Action will immediately be enforced;
- If a camper brings firearms or knives to camp, Second Offense Corrective Action will immediately be enforced.

**Second Offense:** Camper's parents/guardians will be notified and camper will be removed from that day's activities. If onsite at the MAC, the camper will sit in the MAC lobby for remainder of the day. If offsite, parents/guardians will be required to pick up the camper.

**Third Offense:** Camper will not be allowed to return the camp and no refund will be given.

- Sturdy Shoes (hiking boots or good sneakers)
- Rain Gear
- Warm Clothes
- Water Shoes for paddle day (no sandals or flip flops)
- Insect Repellent
- Bow and Arrows for Bow Education Camp (these will be kept in a locked closet)
- Pencil or Pen
- Compass (can be provided if you don't have one)

### Do **NOT** Bring

- Firearms or ammunition
- Knives (including, but not limited to fishing knives, pocket knives, utility knives)

 Required for Minors to Attend a Hunter Education Course

### Parents and Legal Guardians:

Please fill out and sign the form below. Your written permission is required by law to allow people under 16 years old to attend the hunter education course and handle firearms.

**Minimum age for course** – 11 years old. There are exceptions for hunting in other states where hunting is legal for younger people.

**Minimum age for license** – 12 years old. (Adult supervision required until age 16)

### About the Course:

Trained instructors certified by the Department of Environmental Conservation supervise lessons in the safe handling of firearms, and most courses include shooting exercises. Students under 12 years old are allowed to handle only air guns.

In addition to firearms safety, the hunter education course teaches basic outdoor skills and responsible hunting techniques. Emphasis is on helping students become people who will: • Respect people, wildlife, and nature; • Be safe, responsible and ethical hunters; • Appreciate the role of humans as a part of nature; and • support conservation.

Parents are urged to participate with youngsters in completing homework assignments. Discuss the lessons, and help students find the correct answers to quiz questions, without actually giving the answers away.

**NOTE TO INSTRUCTORS:** This form is your proof that instructors are authorized by the parent or guardian of the student whose name appears on this form to supervise that student in firearms handling and shooting exercises in your courses. Refer to your Sportsman Education Instructor Policies and Procedures Manual for rules regarding student equipment and use of firearms by minors in courses. Keep this form for at least one year after the completion of the course.
